#### President's introduction and welcome

At the instigation of AV Executive under Interim CEO Andrew CRISP, Joel MARLEY and his team at AV Community & Partner Engagement approached the Association in late 2024 to gain a better understanding of the history and purpose of TRAAVI.

The result of the initial discussions, Joel determined that TRAAVI's values were more aligned with People and Culture. As a result, we were introduced to Jesse MADDISON the newly appointed Executive Director of People and Culture.

Through the development of the MOU, we have worked closely with Jesse. His support, frank advice and guidance throughout these discussions has helped to rebuild and stabilise the relationship between TRAAVI and AV in the aftermath of COVID.

On Monday 19 May a Memorandum of Understanding (MOU) between The Retired Ambulance Association of Victoria Inc (TRAAVI) and Ambulance Victoria (AV) was signed by Steve MULLIGAN TRAAVI President and Anthony CARLYON Acting CEO of AV.

The MOU covers a period of four years, during which time AV contributes to the administration of the Association financially.

TRAAVI have approached both Monash University (Paramedic Health and Wellbeing Research Unit) and Phoenix Australia (Melbourne University) to conduct research/surveys to better understand and provide a "snapshot" of what physical, traumatic and mental health injuries have and are still effecting TRAAVI members. This now forms a key component within the MOU.

Deb STALLARD has been appointed as TRAAVI Welfare Co-ordinator. Several of the Volunteer Chaplains have joined TRAAVI. Many of whom have gladly accepted the role of Welfare Liaison and/or Chaplaincy within the District.

Gary Grant (former AV Senior Chaplain) continues in his role as Pastoral Care and Chaplaincy Advisor to the Association Committee.

AV People and Culture will consult with TRAAVI in relation to the RAFE Peer Support Program.

Graham DOUGLAS and our computer partners Computer Initiatives have over recent months updated our email system using the traavi.org.au domain. All District Co-ordinators and Welfare Liaisons have Association email addresses.

Key objectives being a simplified email address and importantly improving our cybersecurity. All TRAAVI business is now conducted using only the TRAAVI email domain.

# How first responders are coping with PTSD and mental health tolls that come with saving lives

Drownings, fatal car crashes, and suicides are tragic events most of us hope never to have to encounter.

But for our first responders, attending life and death situations is a daily reality Garry Meredith knows firsthand the toll saving lives can take on the mental health of emergency service workers.

"I always thought I'm one of the lucky ones because it didn't affect me ... and then, in the end, it did," he said.

Mr Meredith has spent more than three decades volunteering as a lifesaver,

Including time as a crew member onboard a jet boat and rescue helicopter on the far north coast of New South Wales.

"My first experience was an unconscious fellow at Shelly Beach [in Ballina] floating

face down in the back of the break," he said.

"In the helicopter we were going to road crashes and body recoveries ... But I think what got to me the most was the suicides and shark attacks and probably resuscitation on kids.

"I didn't know much about PTSD until I was basically diagnosed with it."

#### Key points:

- 10 per cent of emergency service employees have probable PTSD compared to 4 per cent of the general population.
- Around one-fifth of emergency service workers have high levels of psychological stress
- An inquiry finds rural and regional first responders face additional pressures, such as working alone and shift fatigue

#### HIGH PREVALENCE OF PTSD AMONG FIRST RESPONDERS

Mr Meredith's experience is by no means an isolated one.

A recent parliamentary inquiry into the mental health of first responders found 10 per cent of employees have probable PTSD, compared to the general population which is estimated to be 4 per cent.

The Beyond Blue report cited in the inquiry also found more than a fifth of emergency service workers have high levels of psychological stress — almost three times the national average.

"What we do is not a normal job," firefighter Pat Jones wrote in his submission to the inquiry.

## "We are there to help those Australians who are having the worst or last days of their life, and we do it because we care."

According to figures from the National Coronial Information System in 2015, one first responder takes his or her life every six weeks.

The actual number is estimated to be much higher, given that figure does not include part-time or volunteer emergency service workers, nor those who have retired or have been medically discharged.

The inquiry also found rural and regional first responders faced additional pressures not

experienced by their metropolitan counterparts.

These pressures include lower staffing levels, fatigue caused by shift work, community connections to patients or victims, working alone, and having less access to mental health services.

The inquiry made 14 recommendations including extensive data collection on the number of mental health injuries and suicide of first responders, as well as a national action plan on first responder mental health.

#### PEER-TO-PEER SUPPORT A REGIONAL SOLUTION

Terry Mortimer has been a first responder for more than 40 years, with experience as a pilot and crew member onboard a rescue helicopter, as well as a lifesaver and firefighter.

He said one of the hardest parts of the job was dealing with failure.



"There's a lot of success, but there's a lot of failure too," he said.

"But it's not failure due to want, it's failure due to the extent of their injuries."

After dealing with his own struggles and witnessing those of colleagues and friends, Mr Mortimer decided to start an informal support group for first responders in the Northern Rivers.

He said the group met once or twice a month over a pub meal to catch up and check in with each other's wellbeing.

#### "What we're trying to do here is show people it's OK to be injured," he said.

"If they're suffering because there are different things that trigger them, even for anxiety and depression and things like that, there is a way out.

"I've found a lot of people only need somebody to say 'hey, it's OK'."

#### THE NEED TO RAISE PUBLIC AWARENESS

Today is international PTSD awareness day.

It's a cause close to the heart of paramedic and musician Brendan Smoother who knows the importance of raising public awareness around the realities and mental health aspect of emergency service.

"If the broader public is aware of it, then it brings it out in the open and people don't have to feel ashamed about it," he said.

Mr Smoother said his songs like 'Paramedic Suicide' and 'Behind the Seen' were prompted by a growing awareness of colleagues who had been lost to suicide or damaged beyond the point of being able to return to work.

"We're exposed to trauma situations and not just the physical trauma that we do see, but there's all the emotional baggage that comes with that ... and it's prolonged and protracted over many, many years," he said.

"People probably don't think about it in their everyday lives until it's brought to their attention

#### Wounded Heroes Australia.

Wounded Heroes Australia (WHA) are a small, registered charity that supports Veterans and their families during crisis situations. Such as those facing, financial crisis, suicidal ideations and or domestic violence.

Though their 24/7 crisis helpline they deliver critical resources and guidance in times of need.

One of their annual fund raising activities is a 24-hour CrossFit fundraising event called 24 Hours of Heroes which commences the day after ANAZC Day. (26 & 27 April).

This has become an Australia wide event, each Team has up to 6 members. Includes teams of Police, ADF &/or Fire first responders along with of solo participants.

Following a review of this fundraising effort, WHA made the following commitment;

"of providing 20% of the funds raised during this event as a donation to selected first responders such as to Police, Ambulance and Fire selected services around Australia.

Including to State based Ambulance Legacy around Australia. To specifically donate to charities/not for profit associations supporting emergency services."

Following the WHA approach our discussions continue with the Melbourne based representative.

WHA has an Affiliation Program linked to one of their fund raising programs "Coffee4Heroes".

The concept is WHA provides a link to woundedherose.org.au/shop which then enables supporters to purchase WHA specially blended coffee beans, pods and pods from Queensland coffee roaster 'the coffee commune' under Phillip De Della. 100 percent of proceeds go directly to WHA.

In return WHA offer a small return "donation" to their coffee affiliates. We will keep you informed on the progress of these discussions
